#### ANNOTATED PROVISIONAL AGENDA

#### A. BACKGROUND AND OBJECTIVES OF THE CONSULTATION

In resolution 68/279 the General Assembly decided that the Third International Conference on Financing for Development would be held in Addis Ababa from 13 to 16 July 2015, and called upon the regional commissions to hold consultations, as appropriate, the outcome of which could serve as input for the preparations for the Third International Conference.

The Regional Consultation on Financing for Development in Latin America and the Caribbean is being convened by the secretariat of the Economic Commission for Latin America and the Caribbean (ECLAC) and the Government of Chile, and will be held within the framework of the twentieth session of the Committee of High-level Government Experts (CEGAN). This Committee, which was established by virtue of ECLAC resolution 310(XIV), is made up of the developing member countries of the Commission.

#### B. ANNOTATIONS TO THE AGENDA

### 1. Election of officers

Under the rules of procedure of the Economic Commission for Latin America and the Caribbean and in accordance with established practice, the first order of business is for delegations to elect a chair, two or more vice-chairs and a rapporteur.
