BACKGROUND

At the Fifth Meeting of the Technical Committee of ILPES (Buenos Aires, 10 May 1983), it was agreed to hold the Sixth Session in Mexico City on the occasion of the Fifth Conference of Ministers and Heads of Planning of Latin America and the Caribbean.

The Technical Committee is of course the highest collegiate organ giving technical orientation to the Institute. It was set up by Resolution 340 (AC.66) of the Committee of the Whole of ECLA (January 1974) and consists of the Ministers and Heads of Planning of the 37 number countries.
