**ANNOTATED PROVISIONAL AGENDA**

**1. Adoption of the agenda**

The representatives of participating organizations will have before them the provisional agenda of the meeting (LC/L.1748) for consideration and subsequent adoption, with such modifications as they may deem appropriate.

**2. Review of progress made in coordinating the inter-agency project on the use of gender indicators in public policy-making and analysis of the contributions made by participating organizations to its implementation and financing**

(a) The ECLAC secretariat will report on the fulfilment of its mandate as coordinator of the working group on gender indicators of the Inter-Agency Network on Women and Gender Equality (IANWGE) and will present to participants the inter-agency project implemented by the five regional commissions, together with the inventory prepared by ECLAC of gender indicators and tools available in the United Nations system.

(b) The ECLAC secretariat will report on the cooperation and financing agreements concluded regionally with organizations of the United Nations system within the framework of the inter-agency project on the use of gender indicators in public policy-making, in accordance with the agreements adopted at the eighth, ninth and tenth Meetings of Specialized Agencies and Other Bodies of the United Nations System on the Advancement of Women in Latin America and the Caribbean.

(c) The representatives of participating organizations will report on activities being pursued in the area of gender indicators.

(d) Further financing options will also be considered.
