ANNOTATED PROVISIONAL AGENDA

1. Adoption of the agenda

The participating agencies will have before them the provisional agenda contained in document LC/L.2204 for their consideration and adoption, with such modifications as may be deemed appropriate.

2. Regional preparations for activities to commemorate the tenth anniversary of the Fourth World Conference on Women

- (a) The secretariat will briefly review the agreements adopted by the Presiding Officers of the Regional Conference on Women at their thirty-seventh meeting (Santiago, Chile, 29 and 30 November 2004) and will present, for the participating agencies' consideration, the aspects it considers most relevant for strengthening the region's participation in the forty-ninth session of the Commission on the Status of Women (New York, March 2005).
- (b) Taking into account the activities they plan to carry out to commemorate the tenth anniversary of the Fourth World Conference on Women, which they will already have presented at the thirty-seventh meeting of the Presiding Officers of the Regional Conference, the participating agencies will identify activities currently under way that should be strengthened through coordinated efforts by the United Nations system.

- (a) The secretariat will present the report of the Inter-Agency Meeting on the Regional Report concerning Activities relating to the Millennium Development Goals, held in Santiago, Chile, on 6 and 7 October 2004, and will highlight outstanding challenges in relation to the follow-up of the Millennium Declaration from a gender perspective in the countries of the region.
- (b) The participating agencies will comment on their contributions to the regional report on the Millennium Development Goals, with special emphasis on the integration of the gender perspective into the eight Goals derived from the Millennium Declaration.
- (c) The participating agencies will coordinate activities to follow up the implementation of the Millennium Development Goals for 2005, taking into account the weak areas identified in the preparation of the comparative regional report.
 - (d) The participating agencies will define any other tasks they may consider relevant.
